Introduction to Barnardos

Barnardos mission is to transform the lives of vulnerable children affected by adverse childhood experiences.

Barnardos work is delivered by 458 staff and supported by 213 volunteers across 56 service locations nationally. We deliver our services in our centres, in family homes and in schools.

In 2019, we launched a new trauma informed approach that will continue to underpin Barnardos' service provision going forward in our new strategy. This includes an understanding that the impact of adverse experiences in childhood can last a lifetime without appropriate supports and services being put in place.

Barnardos is committed to being cutting-edge and innovative, with capacity to identify and respond to new and emerging needs. Our service provision is informed by research, evidence and best practice. In this context we are committed to the continued development of our staff group.

Barnardos works hard to highlight and represent the needs of vulnerable children and families in the media and political space. We always comment from a position of our experience on the ground of working with vulnerable families. This will continue to be a key focus for Barnardos with the next strategy.

Barnardos services are funded by a mix of statutory and fundraising income streams.

As a Project Worker in Barnardos, I will play a critical role in supporting and working in partnership with parents to transform children's lives. I will work collaboratively with colleagues and external agencies to enable children to achieve their developmental potential, have a positive sense of well - being and feel included. My role will be to assess children's needs and deliver interventions identified to target their specific needs. I will feel

valued and supported by my team and manager through regular supervision and team meetings. I will continue to develop as a skilled practitioner through the training and experience I receive in Barnardos. I will contribute to the achievement of the organisation's strategic priorities and the continued development of Barnardos, to which everyone is committed.



My Job Description

- To assess the needs of the children and the families engaging with the project.
- To plan, implement and review programmes for children/young people/carers/ families based on an assessment of their individual and group needs.
- To be vigilant for signs of physical, sexual and emotional abuse, neglect and any
 concerns regarding the welfare of children. To record concerns promptly and
 accurately. To consult with the Designated Person and take appropriate action
 in accordance with Barnardos Child Protection policy.
- To work with children/young people/carers/families in a variety of ways, including group work, individual work and family work, centre-based and outreach work.

- To key work individual children/young people/carers/families in order to meet their needs and to advocate on their behalf.
- To liaise effectively with families and other statutory, community and voluntary bodies and to attend and contribute to reviews and case conferences as required.
- To work in partnership with other Barnardos services to best meet the needs
 of children and families by collaborating resources with planned interventions
 targeting groups/families of shared need.
- To keep regular records in relation to all aspects of work and prepare reports as required.
- To gather information statistics and prepare reports as required, including administration of databases as appropriate to the role.
- To identify and document to the line manager any unmet needs of children/ young people/carers/families within the service, and to participate in the advocacy work of the organisation as required.

Requirements of all Barnardos staff

- Commitment to the purpose of Barnardos and to work within the values, policies and procedures of the organisation and in the context of current legislation and regulations.
- To participate in regular supervision with your line manager.
- To actively participate in team and staff meetings and service reviews/ evaluations and to contribute to the development of policy and practice with your area of work and within Barnardos as a whole.
- To report any area of concern to your line manager in a timely manner.
- To show reasonable flexibility in relation to hours of attendance to meet the needs of the work. Work during unsocial hours may be required.
- Have a flexible approach to the work in response to organisational change, development and review of best practice.

- Able to act on own initiative and consult where appropriate.
