We need adequate funding for therapeutic support services for all children and young people who need it.

We need all policy, legislation and supports relating to domestic violence and abuse to be informed by children with lived experience.

We need to be consulted on all decisions, because it affects us a lot. *)*

'Develop an engagement model for children and young people'



The Government needs to commit to implementing Operation Encompass as soon as possible.

Operation encompass is a wraparound communication model between schools and An Garda Síochaná, though there are some promising signs, there should be no delay.

Gardaí should help children because they can be affected by the shouting. *?*? – Child, aged 8

'We will examine legislative proposals that would underpin Operation Encompass in the Irish systems'

Our **4 main priority areas** for change are **-**



1. Family Law Courts

Unjust decisions in places meant for justice - Child, aged 14

> Children, regardless of their age, deserve to be heard in court and should be included in decisions that impact them, particularly concerning parental access and visitation.

Judges need to listen to children in court and let them speak when they are ready - it should not be frightening.

We welcome that the Voice of the Child working group has been established as recommended by Family Justice strategy and 3rd National Strategy. In line with the recommendations on the 'Review of the Role of Expert Reports in the Family Law Process', we want to effect change in:

Recommendation 12 & 20: We recommend that the professional diploma for both the court assessors and the children's court advocate have a module on childhood domestic violence and abuse that is informed by children and young people.

Recommendation 15 & 16: We recommend that children and young people are consulted in the development of the voice of the child report template and the children's court advocate pilot.

Recommendation 9: We recommend involving children and young people in creating a child-friendly version of the information provided to them about expert reports.

To ensure that raising awareness and education on childhood domestic violence and abuse remains a priority within the family justice systems.

There should be training for all people who work in the courts.

Family Justice Strategy: 1.1.3 - Goal 5

We welcome the recent development of a webinar on domestic violence and abuse for the family justice sector that includes the perspective of children and young people. However, we stress the importance of keeping the focus on childhood domestic violence and abuse in longterm training for judges and family justice sector workers.





2. An Garda Síochána

I would not see the guards as a first option ... they would come quicker but it wouldn't be my first option **??**

- Child, aged 13

An Garda Síochána should speak with children, if they are willing, when visiting their homes and take their views into consideration when making any decisions or taking any actions.

Gardaí need to know our rights ... children should be allowed to explain what happened.

Current Policy: The 2017 AGS Domestic Violence Intervention Policy outlines current procedures to involve 'eyes on the child', children feel this has not had enough impact on their lived experience.

2 Training for An Garda Síochaná on childhood domestic violence and abuse – that is informed by the voice of the child.

3rd National Strategy:

1.4 — Enable frontline professionals and support staff to have the necessary analysis, skills, and expertise to identify potential DSGBV risks and make appropriate preventative interventions and referrals.

1.4.3 — The Garda College will develop a plan for delivery of a trauma-informed curriculum to the organisation with involvement from GNPSB.

We recommend that An Garda Síochaná collaborate with children/young people to create a video on how to get help and support if they feel unsafe.

Help children to know they can call guards - teach us. - Child, aged 8



3. Tusla – Social Workers

Social Workers – stop rushing **)**

Consult us in matters that affect us and involve us in decision making, especially with plans for access.

Social workers who work with children should have to do training on coercive control and abuse - because it hurts kids so much.

Coercive control and its impact on children should be considered as a form of abuse and taken into consideration by social workers when determining levels of risk of harm to children.

4. Teachers and Education

Teachers should always be open to talking to students and not be afraid of upsetting them **??**

Improve the capacity of schools and teachers to recognise, respond, and advocate for children experiencing childhood domestic violence and abuse. We recommend that children and young people co-produce and develop educational and training resources on childhood domestic violence and abuse to assist teachers and principals in this function.
